- To provide a channel by which issues can be escalated

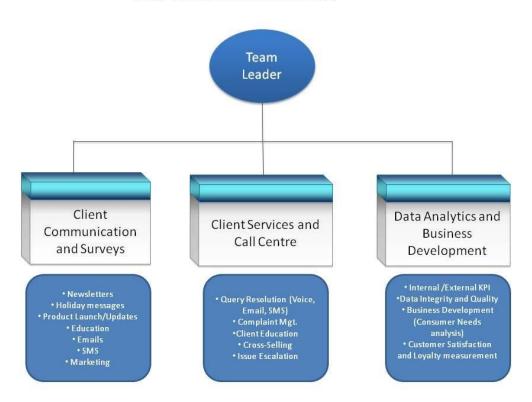
#### 3. Structure

#### **ARM Customer Services structure**

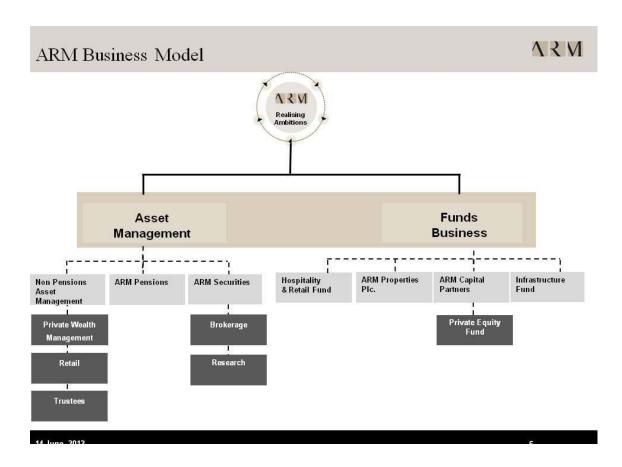

### **6.** Equipment and Resources for Customer Services

All Call Centre agents should have the following equipment and access to the following:

- 1. Telephone handset connected to the main E1 Customer Services line 014488282. 0700 CALLARM and or backup
- 2. Headset connected to the phone handset
- 3. A note pad
- 4. Each desk should be a sufficient distance away from the other desk or screened such that conversations with clients are to an extent private
- 5. Each CSO workstation should be configured for access to the following applications only. The workstations would be locked to this configuration.

### 9. Glossary

**Investment Receipt:** A document sent to investors after confirmation and processing of their initial and additional investments. It includes investor's full names, correspondence and email address, investment amount, price and number of unit is allotted.

**Fund Statement:** A document detailing the position of an investor's account. It gives a summary of all transactions and the value of the investment as at a certain date.

**Registrars:** This body is in charge of issuance of certificate and dividends; they provide up-to-date investment information as it relates to an investor's account.

**Symbols:** This is the application used for capturing and processing stockbroking transactions.

**Investment Center (IC):** This is the retail platform that offers access to investment opportunities in Real Estate, Stock Broking and Mutual Funds.

**Hamilton Hammer (HH):** This is the stockbroking arm of the group where stockbroking transactions are completed.

**Sale Mandate (SM):** This is the document a client completes for the purpose of instructing a sale of stocks

**Purchase Mandate (PM):** This is the document a client completes for the purpose of instructing a purchase of stocks

**Contract Note:** This is the document generated after trade confirmation and includes the following; Name, Client details, Unit Price of Stock(s), Units bought/sold, and charges



#### Appendix 1 – How to use and answer the telephone

- 1. Answer the phone before the 3<sup>rd</sup> ring
- 2. Say "Good morning or applicable, you are through to ARM Customer services and you are speaking to (name), how may I help you.
- 3. Request for ID number and use WRAP or Hitrust to bring up client details
- 4. Ask and verify a few details such as email address and phone number, if details are different to what is within the database, apologise for the delay while you update or note down the changes for later update.
- 5. Ask for details on the query and proceed to resolve
- 6. Suggest any other services, cross-selling opportunities
- 7. End by confirming that you have offered the assistance requested and thanking the client for their custom.
