# Weekly Commentary & Stock recommendation

... for the week 07 – 11 September 2020



#### **Global Economy**

South Africa, which has been in a technical recession since O419, reported a 51% OoO contraction in their GDP for O220 (O120: -1.8%) which translates to a 17.1% contraction YoY. Manufacturing (-74.9% QoQ), Trade (-67.6% QoQ) and Transport (-67.9% QoQ) were the biggest contributors to the quarterly decline in South Africa. Elsewhere, the EU and Japan both announced revisions to the O220 GDP numbers; the EU's GDP was revised slightly upwards to -14.7% YoY from -15.0% YoY while Japan's was cut further to an annualized -28.1% from an annualized -27.8%. Lastly, a 1.0% MoM decline in exports and a 0.6%YoY increase in imports for the month of August pushed China's trade surplus 5.5% lower to \$58.9 billion (July: \$62.3 billion).

#### **Domestic Economy**

This week, the DMO published data on Nigeria's total debt stock for Q220 which showed a growth of 8.3% QoQ by N2.38 trillion to N31 trillion (on an annual basis, total debt rose 21% by N5.3 trillion). Foreign debt stock - which accounts for 36.6% of total debt stock - rose 14% QoQ to N11.4 trillion (\$31.5 billion) and 37% on a YoY basis. To shed more light, 51.97% of the foreign debt stemmed from Multilateral organizations while Bilateral and Commercial loans accounted for 12.54% and 35.48% respectively. On the other hand, domestic debt stock, which makes up 63% of total debt, increased 5% QoQ (and 13% YoY) to N19.6 trillion. Elsewhere, the PPPRA which formerly issued price guidelines for petrol monthly, ceased the issuance of petrol prices. This implies that full deregulation is now in force as petrol prices will now be determined by market forces. Meanwhile, the President gave a directive to the CBN, banning the availability of foreign exchange for the importation of food items and fertilizer. This was done in order to encourage local producers.

#### Equities and stock recommendation

- The bullish trend in the Nigerian bourse was halted this week after 7 consecutive weeks of gains, with the NSE ASI declining by 5bps WoW. The ASI closed at 25,591.95, while market cap ended the week at N13.35 trillion. Banking (-1.33%), Personal care (-1.90%) and Oil & Gas (-1.76%) sectors all experienced declines, while Breweries (+1.77%) recorded major gains. A further probe into the sectoral performance revealed major drivers for the downside were observed in GUARANTY (-5.84%), UBA (-3.88%), ZENITH (-1.15%), UNILEVER (-4.00%) and SEPLAT (-2.50%) WoW, amongst others. On the other hand, gains were seen in NB (+2.62%), ACCESS (+4.65%), WAPCO (+6.67%) and ETERNA (+28.6%) WoW, amongst others.

#### **Fixed** Income

At this week's NTB auction the DMO offered and sold N128.06 billion worth of bills which is N20 billion less than the N148.06 billion that matured. This marks the first net repayment of the year and ٠ the start of further net repayments as highlighted in the issuance calendar. Subscription improved compared to the previous auction with the subscription rate rising to 2.05x (total value of N262.40 billion) from 1.12x while average stop rate declined 20bps to 1.90%. At the OMO auction, meanwhile, the CBN again offered auctioned just a fraction of total maturity - N70billion offered and sold despite N250 billion maturity. Notably, the lyear stop rate here fell 4bps to 8.90%. The combined effect of the net repayments increasing system liquidity and reduced offering at the primary auctions saw demand increase in the secondary market pushing yields down by 38bps WoW to 4.35%. The average bond yield fell 53bps WoW to 7.01% while the average NTB was 23bps lower WoW at 1.69%.

#### The week in Review

- The bullish trend in the Nigerian bourse was halted this week after 7 consecutive weeks of gains, with the NSE ASI declining by 5bps WoW. The ASI closed at 25,591.95, while market cap ended the week at N13.35 trillion. Banking (-1.33%), Personal care (-1.90%) and Oil & Gas (-1.76%) sectors all experienced declines, while Breweries (+1.77%) recorded major gains. A further probe into the sectoral performance revealed major drivers for the downside were observed in GUARANTY (-5.84%), UBA (-3.88%), ZENITH (-1.15%), UNILEVER (-4.00%) and SEPLAT (-2.50%) WoW, amongst others.
- ♦ On the other hand, gains were seen in NB (+2.62%), ACCESS (+4.65%), WAPCO (+6.67%) and ETERNA (+28.6%) WoW, amongst others.

## Weekly Commentary & Stock Recommendation

### **Fixed Income**

#### The week in Review

- At this week's NTB auction the DMO offered and sold N128.06 billion worth of bills which is N20 billion less than the N148.06 billion that matured. This marks the first net repayment of the year and the start of further net repayments as highlighted in the issuance calendar. Subscription improved compared to the previous auction with the subscription rate rising to 2.05x (total value of N262.40 billion) from 1.12x while average stop rate declined 20bps to 1.90%.
- At the OMO auction, meanwhile, the CBN again offered auctioned just a fraction of total maturity – N70billion offered and sold despite N250 billion maturity.
- Notably, the 1year stop rate here fell 4bps to 8.90%. The combined effect of the net repayments increasing system liquidity and reduced offering at the primary auctions saw demand increase in the secondary market pushing yields down by 38bps WoW to 4.35%. The average bond yield fell 53bps WoW to 7.01% while the average NTB was 23bps lower WoW at 1.69%.



This week we feature Nigeria's total public debt stock which rose 8.3% QoQ to print at N31 trillion as at the end of Q220 (Q120: N28.63 trillion). External debt rose 14%QoQ to N11.36 trillion while domestic debt rose 5.4% QoQ to N19.65 trillion. On a YoY basis total public debt was up 20.6%YoY (Q219: N25.7 trillion).
