Full Year Earnings Report

12 months ended 31st December, 2012

#### Recommendation: BUY

- Access Bank (Access) reported 54% YoY growth in gross earnings to N208.3bn for the 12 months ended December 2012. PBT and PAT rose 86% and 125% YoY to N44.9bn and N38.4bn respectively—the latter featuring an even lower tax rate of 4.5% compared to 10.3% as at 9M 12.
- The results included a discontinued operations loss of N4.5bn excluding which PAT rose 151% YoY to N42.9bn.
- Access also announced a N0.85 dividend which translates into a 45% payout ratio, in line with our estimate.

### Liquidity boost fails to materialise

• After rediscounting AMCON bonds in Q3, we expected the improvement in liquidity to help Access capture higher yields on securities and loans. Hence, we limited our expected moderation in asset yields in Q4 to 30bps at 12% in spite of the downtrend in yields that quarter. However, asset yield contraction was a much stronger 110bps, with Q4 12 interest income of N38bn 14% below our estimate. Interest income was flat QoQ as total earning assets grew 8% (twice our estimate) to N1.45 trn in Q4 12. Incidentally, though interest expense rose 8% QoQ to N18.6bn (Q3: +19%)--16% above our estimates--deposits grew an even faster 12% QoQ (vs our 11% forecast) raising questions about how improved funding failed to significantly materialize on revenues.

• After rising strongly through 9M 12, non-interest revenue (NIR) was particularly disappointing in Q4 12, falling 54% QoQ and short of our estimates by a similar margin. The decline was surprising since we expected disposal of ~10branches/month through Sept-Dec 2012 to augment NIR, per management guidance. Given these are audited results, we entertain the possibility that components were restated from prior quarters (as was the case in audited Q2 12 results) especially as other NIR items excluding fee income are lower than 9M levels.

### Sharp reversals in opex trend as provisions weigh on earnings

- A sharp drop in staff costs in Q4 12 to N2.5bn compared with quarterly average of N9.4bn through 9M 12 also suggests restatement. Depreciation & amortization as well as 'other opex' showed similar trends driving Q4 12 CIR to 43% versus 9M average of 65% and our Q4 12 64% estimate.
- Conversely, Access booked a charge of N10bn in Q4 12 in sharp contrast to a N1.1bn write-back in the preceding quarter that had led us to cut our Q4 12 forecasts back to a N2.6bn charge. Whilst the N4bn Q4 portion of the N8bn rediscounting loss on the Q3 AMCON bond sale may possibly have been reclassified as a charge rather than being added to opex as was done in Q3 12, this does not fully explain the significant divergence in both items.
- Largely due to weaker revenue, Q4 12 PBT came in 36% lower QoQ at N5.8bn. Q4 PBT was however 54% below our estimates with provisioning accounting for much of the disparity. PAT was a moderate 9% lower QoQ at N7.8bn boosted by a N2bn tax write-back in Q4 12. Accordingly, while Q4 PBT margin was 11ppt lower than the 9M avg of N24%, PAT margin of 17% was 5ppt below the 9M avg and slightly ahead of our 16% estimate which had factored in a 29% tax charge for Q4 12.

## Q4 12 figures reduce clarity in revising forecasts

- Volatility in quarterly revenues in FY 12, with strong suggestions of a second restatement in the course of the year, makes it somewhat difficult to discern a trend. Nevertheless, asset yield have established a definite downward trend in FY 12, leading us to cut our asset yield estimates for Access by 100bps to 11.5% for 2013. Encouraged by deposit growth matching our expectations, we have generally left earning asset volumes unchanged which at current levels imply a 13% YoY growth for FY 13E. Correspondingly, we expect Q1 2013 revenues to come in 32% higher QoQ relative to a weak Q4 12 and while our FY 13E revenue of N243bn is 6% lower than previous, it still implies a 16% YoY growth.
- FY 12 interest expense of N65 bn is 4% above our estimate on similar funding base which puts WACF at 4.6%, which aligns with the 30bps QoQ improvement we factored into our 4.5% FY 12 estimate. This highlights the potential gains from improvements in Access' funding. We have maintained our NIM (ratio of net interest to interest income) estimates at 63% for FY 13E, trending higher to 65% over our forecast horizon. We expect interest expense to dip 7% QoQ to N17.3 billion in Q1 13.
- Whilst opex has also shown significant variability in 2012, we maintain our 63% CIR forecast for 2013 affirming our expectations for improvement relative to FY 12 in the belief that its staff restructuring exercise is essentially complete. Notwithstanding, Q1 13E opex, at N27bn is more than double Q4 12 figures which we consider to be abnormally low. Moreover, our model forecasts imply a 100bps decline in CIR in the terminal period as revenues rise.
- We err on the side of caution on the issue of provisions based on the industry and Access' recent history. Whilst the Q4 charge could very well prove to be a one-off, we have maintained FY 13E cost of risk at 1.3%, which is one of the highest among tier 1 banks.
- Largely driven by lower revenue estimates our Q1 13E PBT and PAT estimates are 7% and 10% lower than previous at N55 billion and N44 billion respectively, with corresponding margins at 23% and 18%. The sharper reduction in the latter is as a result of a 200bps increment in our tax rate to 20% and translates to EPS of N1.92 for 2013

# Longer term gains sustain valuation upside

Adjusting for tax variation both 2013 PBT and PAT margins are 100bps higher than FY12 in spite of our revisions. Over our forecast horizon, lower discount rates, funding cost and CIR estimates underpin a 16% upward revision in our fair value estimate to **N14**. Access currently trades at 5.6x current PE which compares favourably with tier 1 average of 10.2x as do forward PE of 5.5x (tier 1 avg: 6.8x) and P/Bv of 1x (tier 1 avg: 1.5x). Current market price implies a 34% upside to our fair value estimate and we maintain a **BUY** rating on the stock.

#### ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6 month period (minimum) to the review date. We adopt a 5 point rating system for this category of stocks and a 3 point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for ratings subject to target price deviation is outlined below:
