### Rising competition eats into premium price advantage (N19.63 - SELL)

- Ashaka Cement Plc. (Ashaka) released audited FY 15 results for 12 months ended 31<sup>st</sup> December 2015 wherein revenues declined 18% YoY (9M 15: -16% YoY) to ₩17 billion. PBT and PAT declined 39% (9M 15: -22% YoY) and 40% YoY (9M 15: 13% YoY) to ₩3.2billion and ₩2.8billion respectively.
- Ashaka proposed a dividend of No.15 (FY 14: No.45) which implies a dividend yield 0.6% using price as at last close.

# Revenue declines as price support gradually gives way

• Ashaka reported 26% YoY decline in Q4 15 revenues to ₩2.9 billion, mirroring over 20% YoY cut in cement prices to ₩24,688 per ton and ~6% YoY contraction in volumes to 115KT by our estimates. According to management, the company adjusted ex-factory gate prices in a bid to retain market competitiveness following Dangcem's 18% price slash and increased penetration into the 3.2MTPA North East cement market. In spite of this effort, we believe volume weakness still led to slight loss in Ashaka's market share over 2015 (i.e. -4pps YoY to 18%) in the North East.

Q4 15 COGS declined a slower 6% YoY at ¥2.7 billion relative to revenues as pass-through from lower top-line drove an 82% YoY plunge in Q4 15 gross profits to ¥175 billion with related margins contracting 19.2pps YoY to 6.1% (lowest in the past 10 quarters).

• On other fronts, Ashaka's Q4 15 operating expenses declined 15% YoY to №1.7 billion, reflecting savings from staff rightsizing over the period. Nevertheless, feed-through from weaker top-line as well as Q4 15 other operating cost of №171 million due to one-off redundancy cost following the company's staff cull cascaded to operating loss of №1.7 billion over the review period (vs. loss of №1 billion in Q4 14). Further exacerbating earnings pressures was the reported 63% YoY contraction in net finance income to №465 million, which bloated Q4 15 pre-tax loss by almost three fold YoY to №1.2 billion.

#### Earnings pressure to subsist over 2016 on lower prices

 Overall, Q4 15 result was affected by significant price and volume declines following the company's response to price changes in the industry. Although the company retained a high coal to total energy ratio in its mix, its cost cutting strategy was too tame to offset the impact of top-line pressures on bottom-line.

- Given changes observed over Q4 15, we have reviewed our models to reflect ~21% price cut by the firm and also revised our volume growth expectation 6pps lower to 612KT (+8% YoY) in light of increasing competition in Ashaka's region of domicile. Beyond these, we have also pushed back our expectation for completion of capacity expansion project to YE 2018 (vs. 2017 previously) following our discussion with management at the start of 2016, wherein management hinged its decision to push back expansion plans on broadly weaker market conditions in the region. Given these adjustments, we now forecast 13% YoY contraction in FY 2016E revenue to №15 billion (vs. №25 billion in previous forecast).
- On other fronts, we expect the company to continue to ramp up coal utilization in its energy mix (i.e. north of 90% in 2016E). Specifically, we are of the view that recent industry-wide margin compression makes the option of aggressive coal utilization a no-brainer for Ashaka. Consequently, we expect further gains on this front to ease cost to goods to sales ratio 2pps lower than in 2015 (i.e. 67%) in 2016E. In view of this, we expect input cost to decline 16% YoY to №10 billion and gross profits to come in 8% lower YoY at №5 billion with related margins at 33% (vs. 31% in 2015).
- Although the company significantly reduced administrative costs in the final quarter of 2015, we expect the impact of higher distribution cost—following Ashaka's new strategy of transporting cement to the North West market due to insurgency concerns in the North East—to slightly offset most of these gains. This underpins our expectation of a mild 4% YoY contraction in operating expense to №3.2 billion. Consequently, we expect 2016 operating profits to decline 14% YoY to №1.7 billion (relative to №8 billion in previous forecast) with related margins unchanged at 11% relative to 2015.
- Farther out, FGN's expressed desire to partner with Ashaka in the planned development of post-crisis North East should underpin a return to positive volume growth in the coming years, cascading to revenue growth CAGR of 26.34% over

2016-2020 period (vs. CAGR of over 127% prior to adjustments). This revenue growth projection is firmly tied to our anticipation for an almost three-fold jump in plant capacity size to 3.5MTPA by 2019. Away from top-line, continued energy cost optimization should leave earnings in positive zones over our forecast horizon (i.e. more than double to \$9.5 billion over our forecast horizon). Overall, we note that our price adjustments and push back in the completion time for capacity expansion have significantly narrowed earnings growth expectation relative of prior forecast (more than three folds over forecast horizon to \$16 billion).

• Net adjustments to our model have driven 23% contraction in our FVE to N19.63. Ashaka also trades at 2016E EV/EBITDA of 8.2x relative to 6.1x for Bloomberg EMEA peers. Relative to the stock's last closing price, our FVE is at a discount of 18%, implying a downgrade in our recommendation to SELL (vs. NEUTRAL in previous communication).

#### ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6 month period (minimum) to the review date. We adopt a 5 point rating system for this category of stocks and a 3 point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for ratings subject to target price deviation is outlined below:
