FBN Holdings Plc. (FBNH.NL)

Initial View

Operating cost eats up gains from improved asset quality

- FBN Holdings Plc (FBNH) elected to release unaudited result for its FY 19 operation in line with updated SEC circular on corporate reporting. For clarity, the updated circular requires public listed companies to either file their full year unaudited results within 30 days after the quarter end and subsequently file the audited results within 90 days after the year end or; (ii) not file their full year unaudited results; however, must file their audited results within 60 days after the year end.
- It is important to note that the reported results could be revised upon approval by the CBN. That said, reported PBT and PAT expanded by 12.8% YoY and 3.9% YoY respectively to N73.6 billion and N62.1 billion. The increase in earnings was largely driven by sturdy growth in Non-Interest revenue and lower provisioning. Due to the fact the results were unaudited, no dividends have been announced.
- Non-Interest revenue expanded by 13.2% YoY to ¥149.1 billion on the back of gains on investment securities and debt securities. In addition, increases in E-business fees and credit related fees¹ also supported total growth in NIR.
- FBNH reported loan loss provision of N41.7 billion (-52% YoY) with cost of risk moderating 294 bps to 2.1%. Although, NPL ratio for the full year has not been reported, we believe it should have moderated to single digit as at year end following run rate (Q3 19: 12.7%, FY 18: 25.9%).
- On income lines, net interest income expanded slightly by 0.8% YoY following a faster growth in interest expense (+2.7% YoY). The increase in interest expense largely reflected an expansion in interest expense paid on deposit from banks with most of it due at the early part of 2019. On the other hand, growth in interest income on investment securities expanded 15% YoY, neutering lower interest income on loans to customers and banks. As a result, interest income was slightly higher by 1.4% YoY. On balance, NIM contracted by 58bps mirroring faster decline in asset yields (-81 bps YoY).

- Operating inefficiency continued to remain an issue over the year as operating expense rose 21.5% YoY to N320.2 billion with cost to income ratio increasing to 73.5% (FY 18: 63.4%).
- While we await FBNH audited results, we think NPL ratio should have moderated to single digit as at year end. This implies the bank could be able to pay dividends going forward following CBN's regulation². In addition, upon capitalization of profits, we expect to see improvement in CAR which stood at 15.1% in Q3 2019. In turn, this will provide more headroom for loan growth.
- Elsewhere, we note our concern on the high operating cost which has remained stubbornly high. In addition, we expect the recent revised bank charges to take a toll on NIR given its relatively high contribution to fee income and NIR. However, we expect strong growth in transactions and customer base to provide support.
- We will give update to our forecasts for 2020 following release of the audited result. Our last communicated FVE of N9.12, translates to a STRONG BUY recommendation on our rating scale. FBNH trades at a current P/B of 0.41x, a discount to 1-year average of 0.52x.

Summary of Results

ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6-month period (minimum) to the review date. We adopt a 5-point rating system for this category of stocks and a 3-point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for rating subject to target price deviation is outlined below:
