Flour Mills of Nigeria Plc (FLOURMILL.NL)

Initial View

Earnings drown on lower revenues

- Late yesterday, Flour Mills of Nigeria released its second quarter (FQ2 19) result for the period ended September 2018. EPS remained miserable, as it fell 78.5% YoY to ₩0.35 due to depressed margins from weaker revenue (-8.5% YoY), higher operating expenses (+25.1% YoY) and higher effective tax of 54% (vs. 34% in FQ2 18). With FQ2 19 in, EPS is down 60.6% YoY to №1.25 over the first half of its fiscal year ended March 2019.
- Revenue growth remained weaker YoY which we attribute to lower prices. We recall that Flourmills cut its selling prices modestly in FQ1 19 due to intense competition majorly from smuggled wheat and sugar which impacted on its market share. Breakdown of its revenue in FQ2 19 revealed that the food segment declined 7.2% YoY although, we note that the pace of decline is slower than the slump of 10.5% for the food segment in FQ1 19, suggesting that its strategy to cut prices, particularly for wheat might be paying off.
- Gross margin was down 136bps YoY to 10.9% due to high fixed costs (direct staff cost & depreciation) which outweighed the moderation in raw material costs (-8.8% YoY). EBIT margin contracted by 279bps to 5.6%, pressured by higher operating expenses (+25.1% YoY to ¥7.3 billion). Higher OPEX stemmed mainly from a five-hundred-fold increase in advertising and a 20% increase in admin expenses. We note that OPEX in FQ1 19 was up double-digit and management explained that the growth came from increased advertising for its B2C food products (pasta & noodles) in a bid to maintain market share. We think this continued into the second quarter considering the five-fold jump in advertising expense.

- We observed further balance sheet deleveraging in FQ2 19, as net debt declined to №115 billion from №134 billion and №154 billion as at FQ1 19 and FH1 18 respectively. The moderation in debt was majorly driven by a 28% decline in short-term borrowings (including bank overdrafts). Given this, net debt to equity ratio improved to 76% from 87% in FQ1 19. We believe the moderation in debt alongside the relatively lower yield environment prompted the 31.5% YoY decline in finance costs to №5 billion. The company approached the debt market in September to raise №30 billion in medium term bonds to refinance some its short-term borrowings at a lower interest rate. If successful, we see this providing further support to finance costs and earnings in the second half of its financial year.
- Flourmill trades at P/E and EV/EBITDA multiples of 6.5x and 3.7x compared to Bloomberg Middle East and Africa peers of 18.1x and 7.2x respectively.

ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6-month period (minimum) to the review date. We adopt a 5-point rating system for this category of stocks and a 3-point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for ratings subject to target price deviation is outlined below:
