## Nigerian Breweries Plc- Share Price Trend

- Cost pressures drive earnings to record low. Nigerian Breweries Plc (NB) released its unaudited 9M 17 financial statements wherein revenue rose 14.4% YoY to №222.7 billion while EPS surged 19.4% YoY to №3.03. However, Q3 17 result reveals significant deterioration in earnings with PBT and PAT plunging 84% and 75% YoY to №369 million and №260 million respectively—its lowest on record. Nonetheless, NB declared an interim dividend of №1 per share which implies a dividend yield of 0.6% using last trading price of №161.
  - Looking through the result, we note that input cost pressures remained in the quarter with growth in COGS (+15% YoY) outpacing that of revenue (+13% YoY). According to a trading update provided by the parent (Heineken NV), Nigerian volumes declined by mid-single digit in the quarter even as underlying business conditions remained difficult and consumers continued to trade down. In a reaction to pressured volumes across NB's product portfolio, management left prices flat over the quarter (vs O2 17: +4% OoO), though higher YoY. On input cost, NB's substantial local raw material sourcing exposed it to pressures from elevated domestic cereal prices (YoY: sugar: +46%, sorghum: +14%, Maize: +2%). Furthermore, the parent noted that sourcing FX remained challenging despite an improvement in liquidity levels relative to last year. Consequently, gross profit declined 24% YoY to ₩23.4 billion—the lowest on record while related margin slid 1.44pps YoY to 34.4%.

- NB also faced pressures from higher operating cost (+16% YoY to ¥2.6 billion) which we link to management's move to ramp up volume sold amid intense industry competition with selling & distribution, and admin expenses rising double-digit YoY. This ultimately led to a decline in operating profit to ¥2.8 billion (-83.2% YoY). Furthermore, finance expenses also surged in the quarter (+43.6% YoY) to account for 89% of NB's operating profit in the quarter. We link the elevated finance expense to higher effective rates on outstanding debt (+400bps YoY to 9%). Overall, these pressures drove the steep decline in NB's weakest quarterly earnings on record.
- Currently, NB trades at a P/E of 53.2x compared to Bloomberg Middle and East Africa Peers at 30.9x.
