FX losses offset underlying improvement

(SELL: **№**15.91)

• PZ Cussons Nigeria Plc. (PZ) released its unaudited FQ1 2017 results wherein revenues rose 12% YoY to ₹16.8 billion. Nonetheless, PZ posted pre-tax and post-tax losses of ₹2.4 billion and ₹1.6 billion respectively. The sharp contraction in earnings stemmed from the recognition of unrealized foreign exchange losses of ₹4.7 billion in the review period.

FX losses on trade payables drives negative Q1 earnings

• FQ1 17 straddles the period when CBN adopted a flexible FX regime which resulted in a 43% USDNGN depreciation. Thus, in line with a pattern across FMCGs, PZ's FX loss of ₩4.7billion reflects translation impact of a net short FCY position from trade payables associated with raw material imports. Excluding the FX loss reported, PZ would have recognized a profit of №2.3 billion.



Benign petrochemical prices bolster gross margin

- Beyond the FX issues, the underlying numbers show marked improvement in PZ's performance with gross margin expanding 7pps YoY to 34.5%. Notably, PZ stripped out FX impact from COGS which allowed the effect of benign petrochemical input prices become more visible. In addition to the lower input costs, we believe PZ as with most FMCG companies hiked prices on HPC goods over the period. Consequently, revenues expanded 12% YoY to ₹16.8 billion − modestly ahead of our forecasts of ₹15.9 billion.

FX loss to weigh on FY 17 earnings

- Over the rest of the year, persisting currency weakness which has resulted in price hikes across FMCGs, as firms seek to offset elevated import costs, leads to upward revisions in our sales forecasts. Given the strong FQ1 reading and sizable scope for price increases in the HPC space, we raise our FY17E sales projections 14% from previous to ₹75 billion (+ 8.3% YoY).
- On input costs, persisting supply glut of crude oil and weak demand from major markets underpins our bearish outlook on prices of petrochemical inputs. Thus we project a 7% YoY improvement in gross margin to 34% which translates to FY 17E gross profits of ₹23.7 billion (FY 2016: ₹17.3 billion).
- Given PZ's sizable import-COGS ratio (FY 2016: 81%), the company remains susceptible to sizable foreign currency losses in the near term which should impact negatively on earnings. Using the one year USD/NGN forward rate of № 388.2¹/\$ as a guide to naira depreciation over FY 17, we estimate that the company could record additional FX translation losses of №1.9 billion. Overall, we expect the company to realize FX losses of №6.6 billion in FY2017. Net impact of our adjustments translate to modest recovery to profitability over FY 17E (PBT and PAT of №2 billion and №1.5 billion respectively.

• In the light of these revisions, our blended FVE for PZ declined 5% to №15.91 (Last trading price: №18.64). PZ has lost 27.47% YTD and currently trades at an EV/EBITDA of 11.2x compared to its Bloomberg Middle and East Africa Peers at 8.58x. We maintain our **SELL** rating on the stock.

ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6 month period (minimum) to the review date. We adopt a 5 point rating system for this category of stocks and a 3 point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for ratings subject to target price deviation is outlined below:
