Lower biological asset gains weigh on earnings

(**NEUTRAL:** №38.49)

- Presco Plc. (**Presco**) released FY 2015 audited results wherein revenue rose 14.3% YoY to ¥10.4 billion while PBT and PAT declined 46.7% and 55.3% YoY to ¥4.2 billion and ¥2.3 billion respectively.
- In addition, Presco proposed a FY 15 dividend per share of №1.00 (FY 14: №1.00) which translates to a dividend yield of 2.9% using last trading price.

Volatile biological asset revaluation undermines earnings...


• Earnings were largely undermined by a №1.1 billion loss on biological assets in Q4 15 (Q4 14: №4.1 billion gain) which dragged FY 15 biological asset lower (-81.6% YoY to №1.1 billion). It is noteworthy that the plunge in biological asset gains largely stemmed from restatement of 2014 figures (four-fold higher from prior reading). Had 2014 biological asset gains not been restated, Presco would have reported improved earnings. Specifically, Q4 15 post-tax loss would have declined 17.1% YoY to №1.2 billion while FY 15 PAT would have tripled YoY to №2.3 billion).

...even as costs of higher cultivation weigh on gross margin

Largely reflecting increased cultivation activities, FY 15 COGS climbed 19.2% higher YoY to №3.8 billion. Particularly, upkeep costs of mature plantings, harvesting & laboratory surged (+29.4% YoY to №1.2 billion) in tandem with a 46.2% YoY expansion in Presco's mature plantation to 15.4 kilo hectares. Thus, while the higher plantation acreage was positive for volume, as Presco's FY 15 revenue (+14.3 % YoY) rose faster than domestic CPO prices (+9.9% YoY), gross margin contracted 148bps YoY to 63.5%. (Gross profit: +11.7% YoY). Focusing on Q4 15, revenue climbed for the eight consecutive quarter at 8.5% YoY to №2.4 billion. Nonetheless, gross profit declined 36.1% YoY to №1.9 billion, reflecting higher COGS of №478 million over the period (Q4 14 COGS was negative on account of over accruals in prior quarter).




Figure 1: Trend in Presco's cultivated plantation (Kilo hectares)

• The contraction in gross margin was exacerbated by surging finance costs (Q4 15: five-fold YoY to №126 million, FY 15: +95.2% YoY to №708 million) which tracked similar movement in borrowings (doubled YoY to №6.1 billion). Importantly, amid concerns over the naira outlook, Presco (similar to Okomu) refinanced all of its foreign borrowings (58% of 2014 total debt) with domestic

borrowings. Consequently, Presco reported a 46.7% and 55.3% YoY contraction in PBT and PAT to \$\frac{\textbf{N}}{4}.2\$ billion and \$\frac{\textbf{N}}{2}.3\$ billion respectively, while earnings over O4 15 were negative (pre-tax loss: \$\frac{\textbf{N}}{6}09\$ million, post-tax loss: \$\frac{\textbf{N}}{2}.2\$ billion).

Higher prices and increased production to sustain top-line growth

- Going forward, we expect Presco's expanded mature plantation to support volume growth. Furthermore, amidst higher domestic CPO prices (Q1 16: 34.4% YoY) which reflect recovery in global prices and fallout of CBN's FX proscription to CPO imports, we forecast 40.8% YoY jump in Presco's top-line to N14.7 billion for FY 2016. (Okomu's CPO sales surged 50.9% YoY in Q1 16). Over our forecast horizon, 2016-2020, whilst government policy remains inward looking to plug the domestic CPO supply shortfall, entrance of PZ-Wilmar into Nigeria with a plan to cultivate 50,000 hectares as back-end to their Lagos refinery poses competitive pressures to Presco. Consequently, we now project revenue CAGR of 13.5% vs. 14.4% over the last five years.
- The top-line gains should more than offset higher COGS (2016E:+38.9% YoY, 2016-2020 CAGR: +12.5%), as management guides to cultivating 1000-1500 hectares each year through to 2020, leaving gross profit over the forecast horizon higher (2016E: +41.9% YoY to ₹9.4 billion 2016-2020 CAGR: +14.0%).

- Whilst operating costs (2016E: +27.8% YoY 2016-2020 CAGR: +9.4%) and finance expense (2016E: +6.3% YoY, 2016-2020 CAGR: +5.5%) should mirror increased production activities and borrowings, top-line gains should still filter through to earnings (PBT: 2016E:+37.2% YoY, 2016-2020 CAGR: +14.2%). Furthermore, amidst expectation of lower effective taxes (mean: 2016-2020: 37%, 2011-2015: 33%), we project PAT to grow an average 19.2% per annum over our forecast horizon (2016E: +49.5% YoY to №3.4 billion). Net effect of these assumptions resulted in blended FVE (weighted average of DCF and relative valuation) of №38.17 (vs. №32.64 previously) for Presco.
- Currently, Presco trades at a P/E of 15.1x (27.8x if gains from biological assets are excluded) vs. 8.7x for domestic peer Okomu. On a forward basis, Presco's P/E of 10.1x is similarly at a premium to Okomu's 9.1x. The stock has climbed 6.1% YTD, with last trading price at a 10% discount to our FVE (¥38.49) which translates to a **NEUTRAL** rating.

ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6 month period (minimum) to the review date. We adopt a 5 point rating system for this category of stocks and a 3 point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for ratings subject to target price deviation is outlined below:
