- Our deductions from Seplat Petroleum Development Company Plc. (Seplat's) latest financial report as well as recent discussions with management underpins our view on the stock's capacity to close the valuation gap relative to its African peers. Particularly, an improving and more stable P&L premised on the company's return to past production levels and de-risked earnings via adding a new export route to existing two routes should give investors comfort on earnings performance over 2018. In addition, with capital expenditure (capex) also decelerating from peak levels attained between 2014-16, cash flow is set to expand in 2018.
- The company's Q3 17 result revealed a PAT of \$22.3 million after six consecutive quarters of loses reflecting higher oil exports. Consequently, we expect FY 17 PAT of \$19.4 million relative to a loss of \$166.1 million in prior year. That said, our positive theme on Seplat is hinged on 2018 where we think earnings will be sizable upbeat.
- Upbeat outlook in 2018 amidst persisting risks: Starting off, we expect the company's exports to rise largely reflecting the planned completion of the Escravos pipeline which offers a third export route for the company. Furthermore, the combination of higher crude oil prices and production is expected to support positive earnings momentum. To add. Seplat is likely to call its tax allowance on capex made during the pioneer tax period, which we estimate at \$98 million.
- We therefore raise our FVE from N518.74 to N588.11 after reviewing our model and considering recent updates on the company's operations, precisely its Escravos project and tax position. Against this backdrop, we place an **OVERWEIGHT** rating on the stock.

- On the other side, we forecast finance expense lower to N10 billion (-23.1% YoY, 9M 17: -24% YoY to N8 billion) reflecting moderate FX losses relative to the prior year (+56% YoY). Likewise, we have revised NB's finance income lower to N172.6 million (-59% YoY) to match the nine-month run rate of N124.7 million (-61.7% YoY). Net impact of our model revisions translates to PBT and PAT of N49.4 billion (+25% YoY) and N34.6 billion (+22% YoY) respectively EPS of N4.36. (previously N5.99)
- Tight operating environment to subsist in FY 18: Going into FY 18, depressed real income levels, intense industry competition, weaker volumes as well as NB's relatively more expensive product portfolio guide to a more subdued outlook for revenue growth (+8% YoY to N376.1 billion). In our view, although we expect input cost pressures from raw materials to moderate over 2018E, the higher share of value beers in the sales mix implies that gross margin will remain at below trend levels in the near term.
- NB trades at a current P/E of 35.7x vs 29.8x for Bloomberg Middle East and Africa. We have a SELL rating on the stock with a FVE of N130.75
