Full Year Earnings Report

12 months ended 31st December, 2012

Recommendation: NEUTRAL

After worrisome delays, results moderately upbeat

- United Bank for Africa Plc. (UBA) reported 35% YoY growth in gross earnings to N220bn for the 12 months to December 2012. FY 12 PBT and PAT stood at N52bn and N54.8bn, from respective losses of N26.6bn and N6.8bn in FY 11. UBA also announced a dividend of N0.50, a 30% payout ratio, lagging our 45% payout forecast.
- Q4 12 gross earnings of N49bn were 13% behind our estimates whilst N7.2 billion PBT was 28% ahead of our N5.6bn estimates. At N12.4 billion, Q4 12 PAT was 253% ahead of our forecast due to a N5.2bn tax writeback in Q4 12.

Q4 revenues weaker across board

• UBA's loan book contracted 5% QoQ where we had forecast 4% growth in line with management guidance for 4-7% YoY growth for FY 12. However, sustained growth in funding base helped drive a 9% QoQ growth in total earning assets, which expanded 3pps as a proportion of total assets to 91.6%. Nonetheless, much of the growth remained in low-yielding money market assets which expanded a further 33% QoQ on the heels of a 21% increase in the preceding quarter. Consequently, an 80bps contraction in assets (vs. our 20bps estimate) led interest income 10% lower QoQ and 8% short of our estimates at N35.2bn.

• The softer revenue base extended to non-interest revenue which, at N15bn, was 22% short of our Q4 12 forecast and 13% lower QoQ, failing to reflect the traditional seasonal strength we had anticipated. Fee income was particularly muted, contracting 32% QoQ while trading income of N3.2bn was 4% lower QoQ, after a much stronger performance in H1 12. The weaker fee income was likely (at least in part) related to the removal of N100 monthly flat fee on cards which we reported as at Q3 12.

As cost containment fails to lift operating performance

- The removal of this fee, along with reduction in minimum account opening balance, was aimed at attracting cheaper deposits after an uptick in funding costs in Q2 12 and appeared to be successful in this regard as UBA followed 9% QoQ deposit growth in Q3 12 with a further 7% rise in Q4 12. Positively, after failing to reflect deposit growth in Q3 12, interest expense contracted 16% QoQ to N13.3bn, falling 13% short of our forecast, and putting reported FY 12 WACF at 3%--30bps lower than we had anticipated.
- On the other hand, Q4 12 operating expenses rose 7%QoQ to N28bn, matching our forecast, with much of the QoQ growth coming from personnel expenses (+126%) which had been restrained in Q3 12 in the face of a surge in other opex that quarter. Incidentally, the latter component moderated 64% in Q4 12.
- As a consequence of lower revenues, CIR was 1ppt ahead of our estimates at 64%. Nevertheless, this maintains the broad improvement in this metric over the 78% quarterly average in FY 11.
- Largely on weaker revenues, Q4 12 operating profit of N9.8bn was well below our N14.9bn forecast and 37% weaker QoQ.

Lower loan loss and tax write-backs bolster bottom-line

• At N2.4bn, impairment charge was 6% lower QoQ after reversing net write-backs through H1 12 in the preceding quarter. This was however well below our N9bn estimate for the quarter which had anticipated a typical spike in this metric across the industry in audited financial particularly in view of potential charges on the Air Nigeria loan. Accordingly, FY 12 cost of risk of 0.7% was below our 1.5% estimate.

• The lower charges helped put Q4 12 PBT of N7.2bn--which was 45% lower QoQ--28% ahead of our estimates in spite of weaker than expected operating performance. A N5.2bn tax credit helped push PAT 3% higher QoQ to N12.4bn. Thus, while PBT margin was 8ppt lower QoQ at 14%, PAT margin was 4ppt higher at 25%.

Scope for improved operating performance still clouded by potential provisions

- The 80bps contraction in asset yields in Q4 12 is at par with the average for tier 1 banks which have now all released FY 12 results. Consequent upon subsequent improvement in Q1 13 results we have also factored in an uptick in asset yields for UBA--though at 40bps our expected uptick is pegged at half of the average Q1 13 improvement due to the larger extent of the bank's rotation into money market assets. Coupled with expected expansion in earning assets as funding base broadens, we expect interest income to recover from a weak Q4 rising 21%QoQ in our Q1 13E and underpinning a 20% QoQ rise in Q1 13E gross earnings to N59.4bn for . Our FY 13E revenue of N236bn implies 9% YoY growth.
- Furthermore, we expect the impact of recent initiatives which have helped moderate funding costs to persist and expect 27% QoQ rise in Q1 13E interest expense to N16.9bn, largely on account of higher forecast deposit levels. Nonetheless, in line with peer trends in Q1 13, we also envisage a moderate uptick in costs and forecast a relatively mild 20bps deterioration in WACF by FY 13.
- The uptick in CIR, which would tend to belie management's target of driving this metric below 50% over the near to medium term appears to justify our cautious stance in maintaining a 60% floor over our forecast horizon. Our FY 13E sees higher quarterly opex average based on rising pattern since Q2 12, though this is tempered by potential impact of ongoing efforts to centralize back-end operations. Nevertheless, Q1 13 traditionally marks a slow start for opex and we forecast a mild 3% QoQ contraction to N26.8bn in Q1 13E with forecast CIR at 63%.

- Based on the persistence of charges in Q4 12, UBA's expectations for the N3.4bn charge taken on the Air Nigeria loan to potentially reverse has apparently not materialized and we have continued to accrue our N2.1bn/quarter estimate on this exposure into 2013. Our view appears to be supported by the QoQ loan book contraction which could be evidence of declassification of the N34bn exposure although UBA's failure to report any asset quality metrics somewhat clouds the picture. Coupled with general provision estimates, we envisage impairment charge could rise 18% QoQ in Q1 13E. Our FY 13E provision translates into estimated cost of risk of 1.5%.
- Having been responsible for the main improvements relative to our expectations our belief that the resumption of provision in H2 12 is more likely to persist going forward is primarily responsible for our FY 13E PBT estimate of N51bn being flat YoY whilst PAT at N42bn (FY 13E EPS: N1.32) is 15% lower YoY largely on account of the base impact of Q4 12 tax credit which puts FY 12 tax rate at 1%.

Reduced upside informs downgrade

• Driven by revisions to our cost of equity, our fair value estimate for UBA is 22% higher than previous at **N8.1**. Boosted by the Q4 12 tax credit, UBA's current PE of 5x compares favourably with peer average of 6.95x while forward PE of 6x and P/Bv of 1.35x are at smaller discounts to peer average of 6.4x and 1.4x respectively. After a strong 76% YTD gain, upside from our FV estimate has reduced to 1% over the last closing price and we downgrade the stock two notches from BUY to **NEUTRAL**.

ARM ratings and recommendations

ARM now employs a two-tier rating system which is based on systemic importance of the security under review and the deviation of our target price for the stock from current market price. We characterize systemic importance as a function of a stock's ranking among the group of top 20 stocks by NSE market capitalization over a trailing 6 month period (minimum) to the review date. We adopt a 5 point rating system for this category of stocks and a 3 point rating system for stocks outside this group. The choice of top 20 stocks arises from the consideration that this group of stocks constitutes >75% of overall market capitalization and stocks outside this group are generally less liquid and individually account for <<1% of market capitalization. For stocks in both categories, the basis for ratings subject to target price deviation is outlined below:
