ZENITHBANK - OVERWEIGHT (FVE: ₦29.82): The lender recently announced its full-year 2021 results revealing resilience in operating performance. Despite the effect of the bank's special bills holdings on the interest income line, the bank has been able to shore up fee and commission income and trading income to support profitability. The bank declared a final dividend per share of ₦2.80 and this translates to a dividend yield of 10.37% at close price of ₦27 today. Hence, we maintain a BUY recommendation on ZENITH with a Target Price of ₦29.82, representing a potential upside of 10.44%.
