Weekly Commentary & Stock recommendation

... for the week 15 February – 19 February 2021



Global Economy

• Inflation in the UK edged up to a three-month high of 0.7%YoY in January, up from 0.6% YoY in December 20 and slightly higher than market expectation of an 0.6% YoY. Data from the ONS showed that furniture and household goods (12%YoY vs -0.7%YoY), restaurants and hotels (+1.1%YoY vs 0.1%YoY) and transport (2.1%YoY vs 1.9%YoY) contributed the most to the rise in general price levels, while food prices fell at a softer pace (from -1.4%YoY to -0.7%YoY). In the US, retail sales grew by 5.3%MoM in January (December 20: -1.0%MoM), the highest in the last seven months. This may have been supported by stimulus checks in the US, which may have spurred an improvement in household demand as well as a pickup in business activities. Also, US manufacturing output increased far more than expected in January (up 1.0%MoM vs 0.7% MoM), which suggests that the economy continues to recover from last year's pandemic-related disruptions. Elsewhere, growth in the Japanese economy slowed to 12.7%YoY in Q420 (Q320: 22.7%), however a rebound in exports and capital spending ensured sustained recovery in the world's third largest economy. Export surged 11.1%YoY during the quarter, spurred largely by a resurgence in overseas demand, particularly from China. Meanwhile, capital expenditure grew for the first time in three quarters (+4.5%YoY) as companies proceeded with spending plans that were initially put-off due to COVID-induced disruptions.

Domestic Economy

The Nigerian economy exited recession in Q4:2020 as Real GDP grew 0.11% YoY, per the National Bureau of Statistics' (NBS) publication this week. Cumulatively, this suggests an economic contraction of 1.92% YoY in FY:2020. Aggregate GDP in Q4:2020 stood at N43.56 million in nominal terms - higher than aggregate GDP of N39.58 million recorded in Q4:2019. Real growth of the oil sector was -19.76% YoY in Q4:2020, while the non-oil sector grew by 1.69% YoY in Q4:2020. Elsewhere, the government has increased total debt as a percentage of GDP from 25% to 40%. The new limit will accommodate new borrowings to fund budget deficits and other government obligations, including promissory notes to be issued to settle government arrears, as well as lending from the Central Bank. We note that this may further worsen the debt service to revenue ratio which printed at 83% in FY:2020, thus, adversely impacting on capex spend and the level of productivity in the economy.

Equities and stock recommendation

- The Nigerian bourse closed in the negative territory for the third consecutive week, as the NSEASI shed 63bps WoW to settle at 40,186.70 pts, with market cap coming in at N21.03 trillion. Continued selloffs in the Breweries (-2.16%), Banking (-1.50%) Cement (-0.64%), Food (-0.60%) and Telecoms (-0.56%) sectors eclipsed weekly gains recorded in Oil&Gas (+10.51%) and Construction (+6.73%). Sectoral performances revealed that the prime drivers for the sustained decline were Blue-chip names BUA (-1.77%) and MTNN (-1.10%), as well as STANBIC (-14.00%), DANGSUGAR (-3.65%), NB (-3.28%), ZENITH (-1.20%) and FLOURMILLS (-2.67%) WoW. Conversely, gains were recorded in SEPLAT (+7.07%), JBERGER (+12.78%), GUINNESS (+9.16%), OANDO (+7.72%) and WAPCO (+1.01%) WoW.

Fixed Income

In the secondary market, the average fixed income yield crossed 5% (up 17bps to settle at 5.13%) this week for the first time since June 2020. This was spurred by a sustained rise in bond yields. Upticks in the Jan -2026 (+120bps), Jul-2034 (+82bps) and Apr-2037 (+54bps) papers led the average bond yield up 33bps WoW to settle at 8.76%, while the average NTB yield edged up 3bps WoW to settle at 1.51%. Meanwhile, at the bond auction, the DMO once again offered N150 billion worth of bonds but sold N202.55 billion, (with only N80.55billion via competitive means, however). Subscription rate printed at 1.26x (Total sub-scription: N189.51billion), while the average stop rate rose by 254bps to settle at 11.1%.



January 2021 Inflation Numbers

This week, we feature January inflation report where we saw prices of goods and services increased by 16.47% YoY, the fastest annual price increases in four years. The upward price pressure was driven by the hike in electricity tariffs in September 2020, Naira devaluation and higher PMS prices, which continued to spur both Food and Core inflation northwards on a YoY basis. However, headline numbers rose at a slower pace on a MoM basis in January 2021, printing at 1.49% which is 12bps lower than the previous month. This was largely supported by a 24bps moderation in Food inflation to 1.82% MoM while Core inflation continued to register faster price increases.
