Weekly Commentary & Stock Recommendation

Summary

Global Economy

This Friday, the rouble weakened, tumbling past 77 to the dollar after Russian-backed separatists announced the sudden surprise evacuation of their breakaway regions in eastern Ukraine, spooking already jittery markets. Elsewhere, while brewing tensions between Russia and Ukraine have been the major movers of the stock market in recent times, inflation, uncertainty over monetary policy and stretched valuations are expected to keep stirring asset prices this year, even if geopolitical fears and war rumors subside. A percentage of global stocks dipped while government debt prices rose, as investors take a risk averse position due to the aforementioned geopolitical unrest, increase in oil prices and inflation.

Domestic Economy

◆ Earlier this week, the Consumer Price Index report for January 2022 was released by the National Bureau of Statistics (NBS). According to the report, Nigeria's inflation rate stood at 15.6% in January 2022, which represents a reversal from the uptick recorded in the previous month, when it increased to 15.63% in December 2021. Food inflation increased by 17.13% in the month of January compared to 17.37% recorded in the previous month. On the other hand, Core inflation stood flat at 13.87% in January 2022, the same as recorded in December 2021 despite an increase in the highly weighted sub-components of the index especially the Housing Water, Electricity, Gas and Other Fuel index (+0.38% YoY) and Clothing and Footwear (+0.31% YoY). Yesterday, the National Bureau of Statistics (NBS) also released the GDP report for Q4 2021. According to the report, Nigeria's Gross Domestic Product (GDP) grew by 3.98% (year-on-year) in real terms in the fourth quarter of 2021, showing a sustained positive growth for the fifth quarter since the recession witnessed in 2020 when output contracted by -6.10% and -3.62% in Q2 and Q3 of 2020 due to the economic effects of the Covid pandemic. The fourth quarter growth indicates a strong economic rebound with FY 2021 growth of 3.40% compared to the -1.92% reported in 2020.

Equities and stock recommendation

- ◆ The Nigerian All Share Index (ASI) closed at 47,140.48pts at the end of the week, shedding 0.13% Wtd. While tickers such as Learn Africa (10%), GUINNESS (15.70%) and DANGSUGAR (+3.98%) posted uptrends, the negative turn on DANGCEM (-0.47%), LAFARGE (-1.31%), SEPLAT (-5.88), GTCO (-1.50%) and AIRTELAF (-0.87%) among other tickers nudged the index into negative territory. Sectoral wise, performance was largely mixed. Positive momentum was seen across BREWERS (+2.83%), PERSONAL CARE (+5.35), and FOOD (+1.54%) sub-sectors. On the flipside, the OIL & GAS (-9.61%), INSURANCE (-0.58%), CEMENT (-0.33%), TELECOM (-0.12%), and BANKING (-0.52%) counters all dipped in the week.

Fixed Income

Average yields in the Nigerian Treasury Bills secondary market declined WoW by 25bps to 4.18% as the market closed on a positive note. In the same vein, average yields in the secondary bonds market inched lower by 42bps WoW to 10.81% due to significant buying interest in the MARCH 2025 (down 113bps WoW) and FEB 2028 (down 90bps WoW) instruments which downed yields to 8.93% and 11.10% respectively. At the Bonds auction on Wednesday where the 2026 and 2042 instruments were reopened, we saw increased demand with aggregate bid-to-cover ratio of 3.72x. Demand was concentrated at the short-end with bid-to-cover ratio of 4.34x (Offer: \$\text{0}\$75bn, Subscription: \$\text{0}\$325bn). Consequently, marginal rate for the 2026 instrument declined 55bps to 10.95% compared to 11.50% recorded at the previous auction.



Oil Prices Ease as Prospects of Additional Supply Stoke Fears.

Oil prices extended losses today as the prospect of extra supply from Iran returning to the market overshadowed the fears of a possible supply disruption arising from a Russian Ukraine crisis. OPEC oil basket gained by 8.64% MoM, as some nations still struggle to meet their OPEC+ oil quota. Earlier today, Brent stood at \$92.50 while U.S. West Texas Intermediate (WTI) crude traded at \$91.14. Amid an ease of tension between Russia and Ukraine, we opine a steady decline in oil prices in the coming months.
