Weekly Commentary & Stock recommendation

...for the week 24th January - 28th January 2022



Summary

Global Economy

♦ At the end of its January 2022 FOMC meeting, the US Federal Reserve Bank kept its federal funds rate unchanged at 0-0.25%, but bank officials noted that a rate hike would "soon" become appropriate, as labor market conditions tighten, and inflation remains well above the bank's 2% target. The Fed reiterated its stance to complete the tapering of its bond-purchase program by March, likely setting the stage for a first interest rate hike in Q2 2022. Furthermore, policymakers outlined plans to begin reducing the Central Bank's \$8.9 trillion balance sheet once the rate hike cycle begins. Elsewhere, in its latest World Economic Outlook (WEO), the International Monetary Fund cut its economic growth forecasts for the global economy in 2022, citing lingering uncertainty about the pandemic, inflation and supply disruptions as significant threats to its outlook. The Bretton-wood institution left its projection for FY 2021 unchanged at 5.9% but lowered its forecast for 2022 to 4.4% (Previous forecast: 4.9%), mirroring downgrades to the world's two largest economies, the US (4.0% vs 5.2% in October 2021) and China (4.8% vs 5.6% in October 2021). Furthermore, the pandemic is now projected to cost c. \$13.8 trillion in cumulative economic losses through 2024, compared to the previous forecast of \$12.5 trillion.

Domestic Economy

• Earlier this week, the planned subsidy removal, previously earmarked for the end of H1 2022, was put on hold, as the Federal Government stated it would provide for subsidy payment beyond June. Based on this, the Nigerian National Petroleum Company (NNPC) Limited projected it would cost a cumulative NGN3 trillion to fund petrol subsidy this year at NGN270 billion per month. Elsewhere, the first Monetary Policy Committee meeting of the Central Bank of Nigeria for this year took place this week. The benchmark interest rate was retained at 11.5%, whilst keeping all other monetary parameters constant (asymmetric corridor of +100/-700 basis points around the MPR, CRR: 27.5%, Liquidity ratio: 30%). The committee high-lighted that the Nigerian economy is expected to remain on a positive growth trajectory, following the impressive growth recorded in the third quarter of 2021, reflecting continuous recovery from the recession.

Equities and stock recommendation

• The Nigerian Equities market extended its bullish streak this week as the bourse eked out weekly gains of 0.54%, pushing the market's MtD and YtD returns to 8.17%. On a sectoral basis, the performance was mixed, with the NGX Banking (+4.84%) and NGX Oil&Gas (+3.53%) sectors posting weekly advances while the NGX Industrial (-5.12%) and NGX Insurance (-3.12%) counters ended the week in the red. Buy interest in AIRTELAF (+10.00%), ETI (+44.75%), GUINNESS (+13.98%), INTBREW (+18.00%) and SEPLAT (+4.62%) spurred the positive performance witnessed this week. Conversely, price depreciation in Industrial giants DANGCEM (-8.53%) and BUACEMENT (-2.03%) weighed the sector's performance.

Fixed Income

Average yield in the Nigerian Treasury Bills secondary market declined WoW by 10bps to 4.57%. at the Treasury Bills auction on Wednesday, increased demand pushed marginal rates lower as subscriptions outweighed the offered amounts. Bid to cover ratio at the auction was 3.68x with demand of \$\mathbb{Q}475.63\text{bn}\$ compared to offer of \$\mathbb{Q}129.33\text{bn}\$ and average marginal rate tapered to 3.73% from 3.81% at the last auction. In the same vein, average yield in the secondary bonds market inched lower by 15bps WoW to 11.41% as the yield on the APR-2029 and JULY-2030 instrument fell 57bps and 53bps to 11.93% and 12.09% respectively.



The Nigerian bourse bounces back.

After experiencing a dip on Thursday January 27th, 2022, as the benchmark index dropped by 1.12% and trade volume declined by 9%, the Nigerian stocks recorded 0.43% gain today as the all share index stood at 46,205.05 compared with 46,009.23 recorded the previous day. Trade volume rose by 10.2% when compared with yesterday's figure. Year-on-Year and week-on-week comparison indicate an 8.17% and 0.54% increase, respectively. As companies release earnings results and declare dividends, this should be a major determinant in the movement along the indices in subsequent weeks.
