Weekly Commentary & Stock recommendation

... for the week 08 March - 12 March 2021



Global Economy

Oil prices rose during the week as U.S. gasoline inventories plummeted, but prices were limited due to a surge in crude oil inventories in the aftermath of last month's Texas winter storm. Brent crude settled at \$67.90 a barrel, gaining 0.6%, while West Texas Intermediate (WTI) crude settled at \$64.44 a barrel, gaining 0.7%. In Britain, GDP shrank 2.9% in January as the nation was hit by a new round of coronavirus restrictions. Manufacturing declined for the first time since April 2020, driven by a drop in exports as the country was hit by the effects of its departure from the EU. Exports of goods to the EU plunged almost 41% in January, while imports fell 28.8%. Over in the US, the Senate passed the \$1.9 trillion Covid-19 relief bill. The fund contains direct payments of up to \$1,400 to most American citizens, a \$300 weekly boost to unemployment benefits into September, and an expansion of the child tax credit for one year. It also puts new funding into Covid-19 vaccine distribution and testing, rental assistance for struggling households.

Domestic Economy

The NBS published data on foreign trade in goods statistics for Q420, which revealed a 9.88% YoY fall in total trade to N9.12 trillion. For drivers, the 10.77% expansion in imports to N5.93 trillion as well as a 33.04% moderation in exports to N3.19 trillion - a fallout of Covid-19 induced factors - resulted in the decline in total trade. Major contributors to the decline in export earnings are Crude Oil (-30.53% YoY) and Other Oil products (-19.26% YoY) which accounts for 78.93% and 13.52% respectively of the overall export numbers. On the import leg, Agric (+128.17% YoY) and Raw Materials (+113.12% YoY) were the main driver of the 10.77% YoY increase posted in Q4'20. Hence, we witnessed a negative trade balance of N2.73trn in Q4'20; the highest quarterly negative balance in the 2020 calendar year. On an annual basis, total trade declined by 10.32% YoY to N32.42trn owing to the 34.75% YoY reduction in export while import strengthened by 17.32% over the same period. This led to a negative trade balance of N7.38trn for FY'20 after three consecutive quarters of positive trade balance.

Equities and stock recommendation

- The Nigerian equities market ended the week on a negative note as the NSEASI fell by 1.74% WoW to close at 38,648.48pts, while the market cap came in at N20.22 trillion. CHAMPION (+45.24%), REGALINS (+22.2%), MORISON (+19.70%), NEIMETH (+19.43%) and MBENEFIT (11.43%) emerged as the top gainers in the week, while ETERNA (-18.95%), MEYER (-18.00%), AFRINSURE (-16.67%), UCAP (-16.08%) and ZENITHBANK (-15.61%) closed as the week's biggest laggards on the bourse. Sectoral performances reveal Food (+2.59%) as the best performing sector, and Construction (-5.14%) as the worst performing sector.

Fixed Income

The average fixed income yield in the secondary market rose by 59bps WoW to 5.75% and this was particularly supported by the average NTB yield which rose 130bps WoW to 2.83%. The average bond yield, however, shed 5bps WoW to close at 5.75% with the largest decline witnessed on the Jan-2026 (-130bps) and Mar-2025 (-96bps) papers. At the NTB auction, the DMO offered N88.91 billion which matches the amount due to mature. Total subscription came in at N196.85 billion, 2.21x the amount offered making this the highest subscription rate of the year so far. The total amount allotted was N108.77 billion marking a second consecutive net issuance by the DMO which contrasts to the first 3 auctions of the year where they did not even completely sell what they offered. The 1yr stop rate rose 100bps to 6.50% causing the average stop rate to rise 33bps to 4.00%


