Weekly Commentary & Stock recommendation

...for the week 4th March - 6th March 2022



Summary

Global Economy

• Earlier this week, The Fed raised its benchmark overnight interest rate by 50bps (the biggest rise in 22 years) a move meant to curtail rising inflation amidst surging energy and commodities prices. This however shook the capital markets as several banks also hiked rates in response to the news. While Russia is still facing sanctions from the US and other European countries, President Joe Biden held a meeting with the group of seven advanced countries on additional sanctions on Russia a move to curbing Russia's economic power. Also, the European Union commission proposed changes to the previous embargo which had been placed on Russian oil due to concerns by some countries (Hungary, Poland, Greece, Malta, and Cyprus) as they reiterated that their economy would need time to adjust to these changes. The inflationary and recessionary effects of the conflict and sanctions on Russia may extend through the year as it seems that the conflict might not end soon.

Domestic Economy

- The 28th OPEC and non-OPEC Ministerial Meeting held yesterday, and we saw another increase in Nigeria's oil production quota to 1.772 million barrels per day (bpd) for the month of June from 1.735 million bpd approved for May 2022. This happened as the Organization maintained the upward oil production quota approvals for Nigeria. Compared to the new quota of 1.772 million bpd, daily average production by the country for the month of March 2022 stood at 1.49 million bpd. This represents a 1.90% and 14.52% decline in production levels on a month-month and year-on-year basis respectively. The Country has been besieged with incessant vandalism and oil theft which has dampened output level and consequently Government's revenue, even in a higher oil price environment.
- Earlier in the week, the Nigerian Communications Commission (NCC) issued final letters of awards of 5G spectrum to MTN and Mafab Communications. The licensees are expected to commence roll out of 5G services effective from August 24th, 2022. With this roll-out, we expect to see a more digitized economy which impact would positively affect service delivery and user experience for customers.

Equities and stock recommendation

- Despite global inflationary trends and uncertainties which has affected the global capital market, the Nigerian bourse has witnessed significant gains. We witnessed the NGX All Share Index cross over to 50,000 pts this week and closed the week on a bullish note as the All-share index gained 2.63% WoW to settle at 50,937.01pts (highest since 2008). This week, the Consumer goods (+7.25%), Industrial (+3.22%) and banking indices (+0.26%) all recorded positive momentum while the Insurance indices (-1.98%) and Oil and Gas (-1.10%) closed on a negative note. Leading the gainers chart are CHAMPION (+32.5% WoW), INTBREW (+32.4% WoW) and CADBURY (+32.2% WoW), while ABCTRANS (-26.7% WoW), OANDO (-11.7% Wow), and MANSARD (-9.8% Wow), led the laggards.

Fixed Income

This week, the Fixed Income market closed on a bearish note with yields up in both the NT-bills and Bond secondary market. In the NT-bills market, average yields increased marginally by 3bps WoW to 3.73%. This came after selloffs were recorded in the short to mid tenor bills. In a similar vein, the secondary Bond market recorded an 11bps rise in average yields to close at 10.75%. We traced this largely to the selloffs reported on the MARCH 2027 (+28bps WoW), FEBRUARY 2028 (+30bps WoW), APRIL 2029 (+32bps WoW) and JULY 2030 (+24bps WoW) instruments.


