## **Weekly Commentary & Stock recommendation**

... for the week 25th February - 4th March 2022

#### **Global Economy**

The Russia - Ukraine conflict continues to impact the oil market as oil price gained 2.61% to settle at \$113.34pb at the close of business today. While Russia suffers record-breaking economic isolation with more EU sanctions expected, a ban on Russian-flagged ships at European ports is imminent. The U.S government further imposed sanctions against Russian oligarchs to pressure President Vladimir Putin. Finland also joined NATO and other countries on imposing sanctions on Russia in a bid to force it to stop the conflict. As at today, Russian forces in Ukraine seized Europe's biggest nuclear power plant in Zaporizhzhia an action which the U.S. Embassy in Ukraine tagged a "war crime". The impact of the conflict on the European markets cannot be overemphasized as European stocks sank to near one-year lows on today, as auto and bank stocks took a battering on reports of the seizure of the nuclear power plant on fire amid fierce fighting between Ukraine and Russian troops. The pan-European STOXX 600 index (.STOXX) fell 7% this week - its worst such fall since the pandemic-fueled selloff in March 2020. The index has lost over 6% since Russia launched its invasion of Ukraine last week. Over in Hongkong, there was a net outflow of over 71,000 people in February, the most since the beginning of the pandemic, compared with 16,879 in December as COVID cases spiral and rules tighten making living in the state harsh and unbearable. The city reports daily cases of close to 60,000, after a three-month streak of no infections at the end of 2021.

#### **Domestic Economy**

In a move that stayed true to our expectation, the Nigerian National Petroleum Corporation exercised its pre-emptive right of first refusal on ExxonMobil's \$1.6bn Assets' Sale to Seplat. This is a sequel to the movement in market sentiment following the impression of an additional production legroom amid the rising crude-oil prices for Seplat. Notably, this development does not amount to a cancellation of the transaction by the NNPC. On the contrary, it is an exercise of its right of first refusal which would in turn create competition for Seplat in its bid to acquire the asset. In the week, Stanbic IBTC Purchasing Managers' Index was released. The reading for February stood at 57.3pts, an improvement on the 53.7pts reported in January. The reading peaked at that range (57.3pts) for the first time in two years, and signals improving demand and a likely uptick in consumer prices following the recent trajectory of commodity and energy prices.

#### Equities and stock recommendation

On the last trading session of the week, the equities market closed on a negative note for the 3rd consecutive day as the All-share index dipped by 6bps to settle at 47,268.61 points. On a week-on-week basis the ASI declined by 13bps. This is following profit-taking activity after seeing the bullish run in the market. The market breadth came in at 0.4%. Leading the top gainers list are SEPLAT (20.25%), LINKASSURE (16%), FCMB (11.80%), COURTVILLE (11.11%) and SIAMLETF40 (10%) while RTBRISCOE (-32.98%), LEARNAFRICA (24.14%), NGXGROUP (-18.43%), NIGERINS (17.86%), NEWGOLD (16.90%). Sectoral wise, performance was mixed. Positive momentum was seen across OIL & GAS (+41.13%), PERSONAL CARE (+2.02%), and TELECOM (+0.58%) respectively. On the flipside, the BANKING (-2.26%), FOOD (-1.19%), BREWERS (-1.19%), INSURANCE (-0.30%) and CEMENT (-0.18%) counters all dipped in the week.



#### **Fixed Income**

Average yields in the Nigerian Treasury Bills secondary market declined WoW by 27bps to 3.48% as investors took position at the long-tenor instrument and the yield declined 1.1% to 3.97%. In the same vein, average yield in the secondary bonds market inched lower by 44bps WoW to 10.19% due to significant buying interest in the JULY 2030 and APRIL 2029 instruments with yields down 153bps and 107bps respectively to 10.72% and 10.37%.



#### **Oil price rise as Russia-Ukraine Conflict lingers**

As the Russia-Ukraine conflict entered its first week, Brent crude oil price rose by 14.39% week-on-week to settle at \$113.34pb. With active forces in Ukraine, whislt sanctions are being imposed on Russia, oil price could continue to remain elevated. Nigeria's potential benefits from the oil price rally is still dampened by higher landing costs from petroleum products importation and ultimately, higher subsidy costs.
