## **Weekly Commentary & Stock recommendation**

...for the week 1st November - 5th November 2021



### Summary

### **Global Economy**

• During its November 2021 meeting, the U.S. Federal Reserve Bank officially announced plans to begin dialing back its crisis-era support measures but stopped short of penciling in a sooner-than-expected hike in interest rates. Slated to start later this month, the Central Bank will reduce the monthly pace of its net asset purchases by \$10 billion for Treasury securities and \$5 billion for agency mortgage-backed securities, although policymakers are prepared to adjust the pace of purchases if warranted by changes in the nation's economic outlook. On the price front, the Fed noted that while inflation remains elevated, price pressures are driven by pandemic-related imbalances in demand and supply that are still expected to be largely transient. In a slightly similar move, the Bank of England kept its benchmark interest rate at a record low but voted to leave its bond-buying programme unchanged as policymakers weighed the risk of rising price pressures against a possible upturn in unemployment rate following the end of the government-led Furlough schemes in September 2021. The Central Bank did however state that a rate hike might become a necessity over the coming months, with CPI Inflation now expected to peak at around 5% in April 2022.

### **Domestic Economy**

◆ The National Pension Commission has begun clamping down on employers who deducted monthly pensions from employees' salaries but failed to remit them to their Pension Funds Administrators. As such, the pension industry regulator has appointed recovery agents to go after the defaulting employers to recover outstanding liabilities. PenCom revealed that workers who attained the age of 50 and retired under the Contributory Pension Scheme but were not entitled to monthly pensions rose to 123,758 as of the end of June 2021. Elsewhere, The Nigerian National Petroleum Corporation revealed that a total of NGN864.07bn was spent between January and September subsidizing Premium Motor Spirit, popularly known as petrol. This amount represents 31 per cent of the total revenue of NGN2.7tn generated by the corporation between January and September. An analysis of a report submitted by the corporation to the Federation Account Allocation Committee at its last meeting showed that the NNPC did not incur petrol subsidy cost in January but spent NGN25.37bn on subsidizing the product in February.

### **Equities and stock recommendation**

- ♦ At the end of a choppy trading week, the benchmark NGX All-Share Index edged down 0.06% as the Nigerian bourse posted its first weekly loss in two months amid profit taking by investors. The sectoral performance was broadly negative with the PERSONAL CARE (-10.62%), OIL & GAS (-1.64%),BANKING (-1.29%) and BREWERS (-0.70%) counters ending the week in the red while the CEMENT (+1.07%) sector posted a weekly gain. Price depreciation in UNILEVER (-14.42%) WoW and PZ (-6.25%) anchored the losses we saw in the PERSONAL CARE sector while buy-interest in industrial giant BUACEMENT (+3.47%) drove the positive finish in the CEMENT space.

#### **Fixed Income**

The secondary market traded mixed this week, with bullish sentiment in the NT-Bills space while the bonds segment was quiet for most parts of the week. At the short end of the yield curve, mid-dated bills attracted the most demand, leading the NTB benchmark down 15bps to 5.33%. Over in the bond segment, the general sentiment was tepid with no major triggers in the market. The average yield curve inched up 4bps to 10.89% as investors sold off on their mid (+9bps) and long dated (+5bps) secondary holdings.




