Weekly Commentary & Stock recommendation

... for the week 25th October - 29th October 2021

Global Economy

The U.S. economy grew at a considerably slower pace in the third quarter of 2021, as a resurgence in COVID-19 cases further exacerbated global supply chains, leading to a shortage of goods that consequently hit the brakes on consumer spending. GDP expanded by an annualized rate of 2% last quarter (Q221:+6.7%) according to the government's advance estimate as spending on long-lasting manufactured goods dropped by 26.2%QoQ while the weaker-than-expected growth also reflected declining pandemic relief funds from Washington. Looking ahead however, we do not expect the slower growth figure to sway the Fed from its tapering plans, set to begin next month, as recent signs point towards momentum regain in economic activities. Elsewhere, the International Monetary Fund (IMF) chief, Kristalina Georgieva, called on world leaders to take "joint and decisive actions" on a number of pertinent issues facing the global economy. In a rallying call to G-20 leaders, who are set to meet in Italy this weekend, the Fund's Managing Director urged them to assume leadership roles in the distribution of vaccines, take proactive steps to bridge the funding gaps that exist due to the large disparities in fiscal firepower as well as commit to achieving net-zero carbon emission by 2050.

Domestic Economy

Nigeria's central bank digital currency (CBDC), the eNaira, launched this week following an announcement by President Muhammadu Buhari. The President said the digital currency and the blockchain technology it uses can foster economic growth and increase the GDP of Africa's biggest economy by \$29 billion over the next 10 years. Nigeria's Central Bank (CBN) Governor Godwin Emefiele said that around 500 million eNaira have already been minted in lieu of the digital currency going live. Development of the eNaira was carried out by fintech company Bitt, whose Digital Currency Management System is also behind the East Caribbean Central Bank's digital currency DCash. Elsewhere, the Board of FBN Holdings Plc has announced that Mr. U.K. Eke, MFR, is poised to retire as Group Managing Director, FBNHoldings, Nigeria's foremost banking and financial services group, following the successful completion of his two-term tenure and his Notice of Retirement which he tendered August 10, 2021.

Equities and stock recommendation

- The Nigerian equities market extended its winning run as investors sentiment remained positive, spurred by bargain hunting across counters amidst the earnings season. The overall market capitalization rose by 0.66% WoW to NGN21.94trillion while regarding the performance of the NGX market indices, the benchmark NGX All-Share Index closed up 0.66% WoW, taking the index's Year-To-Date gains to 4.39%. All other indices closed in the green, with the NGX Insurance (+5.28%), NGX Oil&Gas (+4.04%) and NGX Banking (+2.43%) counters leading the way. Price appreciation in High cap names AIRTELAF (+1.30%) WoW, MTNN (+0.92%) WoW, ZENITH (+1.00%) WoW, GTCO (+0.53%) WoW and medium cap stocks like GUINNESS (+23.05%) WoW, WAPCO (+8.00%) WoW, TOTAL (+17.52%) WoW and OKOMU (+7.66%) WoW boosted the index this week. On the flip side, investors booked profits on FBNH (-9.80%), STANBIC (-4.88%), DANGSUGAR (-5.56%) and NESTLE (-0.36%).

Fixed Income

The secondary market traded mixed this week, with contrasting movements witnessed at both ends of the yield curve. In the NT-Bills space, the market was mostly quiet but selloffs in long-tenored bills led the benchmark curve up 10bps to 5.48%. Over in the bond segment, buying interest in the mid (-25bps) and long-dated (-6bps) maturities drove average yield across the curve down by 7bps to 10.84%. In the primary market, the CBN offered NGN150.04bn but sold NGN235.04bn worth of treasury bills split across the three maturities (91-day: NGN2.68bn, 182-day: NGN2.02bn, and 364-day: NGN230.34bn). The auction attracted a bid size of NGN431.11bn, resulting in a bid-to-cover ratio of 1.83x. With demand once again skewed towards the 364-day bill, stop rate on the maturity trended lower (down 26bps to 6.99%) while the 91-day and 182-day bills cleared at previous action levels.




